5.0 REPORT ON IN-CAMERA MATTERS

5.1 Motion to Report on Decisions Approved In-Camera

The Chair reported on the following in-camera decisions and discussions: the Board received an update on Ontario Health Teams; The Board as Members of the Corporation approved a motion to elect Anne Desgagnes as a member of the KHSC Board; the Board agreed to proceed with the recruitment to fill Bruce Lounsbury vacant seat – skill set is for a Chartered Professional Accountant; the Board approved revisions to the terms of reference of the KHSC Board Committees to bring forward an additional patient experience advisor to serve; the KHSC Board, as a Class B shareholder, approved Emily Leslie and Dr. Cathy McLellan's appointments on the UHKF Board; the Board was briefed on a governance chairs working group that has been established between KHSC, Providence Care and UHKF to review issues of conflict for cross appointed positions; the CEO briefed the Board on KHSC's transitional care unit; an update on KFL&A addictions and mental health redesign was provided; the Board was briefed on patient flow challenges and ALC volumes; information on funding impacts for services provided to military members; update on KHSC's redevelopment project; and the CEO confirmed that searches are underway for the VP/Vice Dean Research; Dean, Faculty of Health Sciences; and Head for the Department of Surgery.
